- I. The Department of Biological Sciences (hereafter referred to as "the Department") has established National Sun Yat-sen University Department of Biological Sciences Course Committee (hereafter referred to as "the Committee") for appropriate and effective planning the Department's curriculum and faculty arrangement.
- II. <u>The Committee comprises four committee members. In addition to the chairman of the Department, who serves as the convener and an ex officio member, three other members are appointed among full-time faculty members during department general meetings. The term for committee members is one year with the prospect of re-election. Depending on meeting purposes, student representatives may be nominated to attend relevant meetings and discussions.</u>
- III. Objectives of the Committee:
 - A. Establish the education goals of the Department.
 - B. Plan the overall curricula of the Department, allocation faculty members, and promotion of relevant tasks.
 - C. Execute and ensure the integrity of the Department's course plans to achieve the goals and effectiveness of the Department.
 - D. Incorporate the recommendations of faculty members and students to improve the Department's course plans.
 - E. Review the establishment of new curricula and the changes in extant curricula, and send resolutions to the college or relevant meetings for approval.

- IV. The Committee shall hold <u>two</u> meetings per semester, with additional unscheduled meetings when necessary. Committee meetings must present an attendance rate of 2/3 prior to review. Decisions must be supported by 50% of the attendees.
- V. Committee meetings may invite the attendance of relevant parties when necessary.
- VI. The present guidelines shall be <u>implemented</u> following approvals of department general meetings, <u>the College Course Committee</u>, the University Course Committee, academic <u>affairs meetings</u>. The same procedure shall be carried out when amendments are to be made.
