- I. The Guidelines of Faculty Evaluations (hereinafter referred to as "the Guidelines") are specifically issued by the Department of Biological Sciences (hereinafter referred to as "the Department") of National Sun Yat-sen University (NSYSU) in accordance with NSYSU's "Regulations of Faculty Evaluations" in expectations of improving teaching, research, counseling, and service qualities of faculty members of the Department.
- II. All full-time faculty members of the Department shall be evaluated in accordance with the Guidelines. After being approved for the first evaluation, a faculty member is then evaluated every five teaching years.
- III. In accordance with NSYSU's "Regulations of Faculty and Research Personnel Appointments," newly appointed faculty members of all levels are considered as passing one evaluation if they are reappointed for the <u>first time</u> following their first appointed periods. <u>Full-time faculty members of all levels</u> are considered as passing one evaluation for each when they are promoted from their appointed positions.
- IV. Those who <u>qualified for non-evaluations</u>, as defined by NSYSU's "Regulations of Faculty Evaluations," may be exempt from being evaluated.
- V. Faculty members of the Department are evaluated in three items—teaching, research, and counseling and services—with a total score of 100 points. Teaching, research, and counseling and services each accounts for 40%, 40%, and 20% respectively of the overall evaluation. Faculty members who personally hold the Catastrophic Illness Cards or the Disability Manuals may have proportions of their evaluated items adjusted within limits in references to NSYSU's faculty evaluation regulations.
- VI. Faculty evaluation items and calculations of scores are <u>in accordance with table of indications of NSYSU's faculty evaluation regulations</u>.
- VII. Faculty members whose evaluations are not approved shall be penalized starting from the next school year. Penalties include no salary raise allowed, not being eligible for applying research leaves or transfers, not allowed to acquire part-time jobs or deliver lectures outside the university, etc. Faculty members whose evaluations are not approved may only apply for

- re-evaluation one school year later, and have their penalties removed in the next school year after re-evaluations have been approved.
- VIII. Faculty members shall submit relevant information and documents for evaluations. Personnel who do not submit relevant documents are considered as not approved. Faculty members during transfer periods, on leaves with pays, or on leaves without pays in the evaluation year, who are not at the university to submit relevant documents, may delay their evaluation processes until returning to the university.
 - IX. For matters unaddressed in the Guidelines, please refer to relevant regulations.
 - X. The Guidelines shall be implemented following establishment by the department general meetings and approvals of the College and University Faculty Evaluation Committees. The same procedure shall be carried out when amendments are to be made. The regulations have been implemented since School Year 95.
